



RE: 2021/22 Admissions Updates for NAIT Authorized Agents

NAIT will start to accept applications beginning **October 1st, 2020**, for credit programs starting in the 2021/22 Fall (1211), Winter (1212), and Spring terms (1213). Here are the the major changes/updates that we would like to draw your attention to:

NEW! Provision admission to [Bachelor of Technology in Construction Management](#) (Effective Fall 2021 intake) [based on 3 courses completed within first term of admission](#)

- We can now offer provisional admission to international students for the [Bachelor of Technology in Construction Management](#) program if they:
 - ✓ Completed a related diploma with a minimum GPA of 2.3 (see program page for details)
 - ✓ Complete within the first term of admission 3 courses: BTCM 3270, BTCM 3150, and BTCM 3160, which will be used towards completion of their BTECH-CON credential.
- We cannot provide conditional admission for provisional admission. Students must submit official documents and have already met all requirements for admission.
 - ✓ Remember, official documents include two stamps, your signature and the date you received the documents.

CHANGE! Provisional admission to Business Administration diploma [based on ESL Level 6](#)

❖ Pathway: ESL → BUS

- There will no longer be a Business Administration with ESL program.
- Instead, we are offering provisional admission directly into Business administration diploma programs if students:
 - ✓ meet the academic requirements for business
 - ✓ meet the lower [ELP requirements for business](#)
 - ✓ Apply to ESL and complete NAIT's Level 6 ESL course within 1 year of starting program
 - ✓ Submit a complete, business program application by:
 - July 31st for the fall intake
 - November 20th for the winter intake
 - March 31st for the spring intake
- Students can submit proof of ELP prior to the business program start in order to receive full admission after receiving provisional admission.
- Once the business program starts, they must complete ESL Level 6 within the year and cannot use other forms of ELP.
- We cannot provide conditional admission for provisional admission. Students must submit official documents and have already met all requirements for admission.
 - ✓ Remember, official documents include two stamps, your signature and the date you received the documents.

REMINDER! NAIT equivalency test is an option for international students!

- [NAIT equivalency tests](#) may be used to fulfill an admission requirement. There are no limits to how many equivalency tests a student can take in order to meet the requirements.
 - ✓ Admissions will always review the highest grade, rather than the date completed.
- Equivalency tests are available for: English 30-1, English 30-2, Math 30-1, Math 20-1, Biology 20, Biology 30, Chemistry 20, Chemistry 30, Physics 20, Physics 30. Equivalency tests **cannot** be used to meet ELP.
- Students can request for our equivalency testing from overseas, as long as they are able to arrange for an alternative invigilation site. Please see [here](#) for the details on how to get a site approved.
- If your student will be using NAIT's equivalency test to meet our entrance requirement, please upload their test booking confirmation to the MyNAIT portal.
- Once the test is complete, upload their test results to ensure that the Registrar's Office uses them for admission.

CHANGE! ELP for students in NAIT's ESL classes

- If a student is currently attending NAIT's ESL class, we will use their ESL grades from the class to meet ELP.
 - ✓ Admissions will not accept another form of ELP (such as a duolingo or IELTS test) to meet ELP if they are enrolled in our ESL program.

- Applicants who do not meet high school requirements for the programs below can be considered for admission if they completed post-secondary study in a related field, with a minimum AGPA. **Please visit the individual program pages for more details.**
